3. CONTENT

The course covers all the basic institutions of European and global governance and is structured into two modules: the first is the presentation and analysis of the historical evolution, the role and function of the European institutions, and the second one in the presentation and analysis of the historical evolution, role and the functioning of the international institutions.

The European idea and the European movements, the Schuman Declaration and the establishment of the ECSC, the EEC and the EAEC The main events of the period 1960-1990.
